


Constituency of Moose Jaw North

Her Majesty's Writ bearing the date March 8th, 2016, having been directed to me, public notice is now given:

- 1. That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency
- 2. That I will, on March 19th, 2016, from 9:00 a.m. until 2:00 p.m. attend at Moose Jaw Town 'n Country Mall 129A/130 1235 Main Street North, Moose Jaw, to receive nominations.
- 3. That in case voting of voters is required, polling places will be open on April 4th, 2016, from 9:00 a.m. until 8:00 p.m. as follows:

That at Moose Jaw Town 'n Country Mall - 129A/130 1235 Main Street North, Moose Jaw, on April 16th, 2016 at 9:00 a.m., I shall open the ballot boxes and, in the case of a general election, I shall open the ballot envelopes containing the ballots of voters at hospitals and remand centres, count those ballots and, where there are absentee voters and displaced voters, open the ballots of those voters and count those ballots and make the addition of the votes given for each candidate and declare elected the candidate having the largest number of votes.
